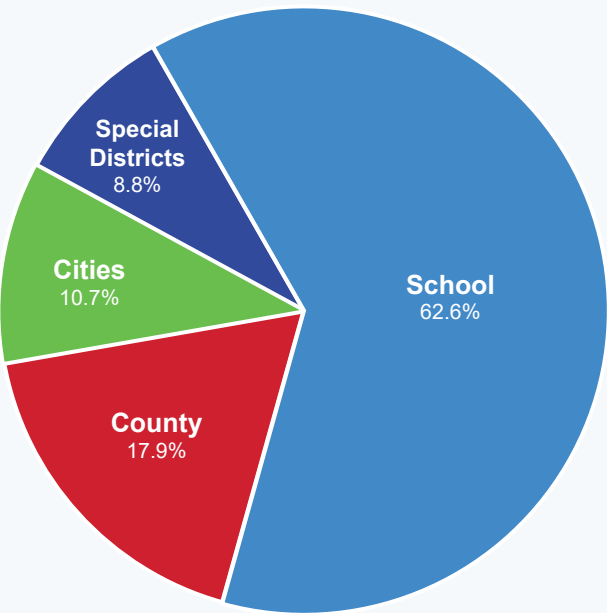

Late 2021 payments and delinquencies. Payments made after November 30, 2021 must include a penalty of either 2.5% or \$10 for each parcel, whichever is larger. If you pay your full 2021 tax bill by January 31, 2022, the penalty is reduced to the greater of 1% or \$10. If 2021 taxes are not paid on or before January 31, 2022, interest is charged from January 1, 2022 at the rate defined by Utah State code 59-2-1331.

Property value reappraisal. The value (appraisal) of your property may be reviewed in 2022, as required by Utah State code 59-2-303.

Property tax relief programs. If you are age 66 or older or a widow/ widower of any age and your 2020 total household income was less than \$34,666, you may qualify for the Circuit Breaker program. For questions relating to property tax reduction programs for Veterans, Military deployment, low income, blind or other reduction programs call (801) 451-3243 [OPTION 2](#).

Partial payments. If you pay part of your tax bill, you have the right under Utah State Code 59-2-1317, to tell us how you want your payment to be used. You can allocate the payment between amounts due for total property tax, assessments, delinquent local district fees, and any other amounts due on this notice.

PREPAYMENT PROGRAM INFORMATION

You have the option to prepay next year's taxes monthly. If you want to participate, there are two options. The monthly payment must be greater than \$10.00. If a mortgage company pays your taxes, you are not eligible to participate. With either option, each monthly payment will be 1/10 of this year's (current year) taxes. There will be nine payments, January through September next year. The remaining balance will be due November 30 next year.

OPTION 1 This option uses coupons, due the 5th of each month, January through September. If you have participated in the past, your coupons for next year are sent separately. If you have not participated and want to, please call the Treasurer to request a coupon book.

OPTION 2 This option is for automatic payments from your financial institution. To sign up go to: www.daviscountyutah.gov/treasurer There is a link to [ACH Authorization Form \(Property Tax Prepayment Program\)](#). Click on this link, fill out the form, attach a VOIDED check, and mail to: Davis County Treasurer P.O. Box 618 Farmington, UT 84025. Your Tax Notice next year will show the balance of tax that will be withdrawn from your financial institution on November 30 next year AND the amount of your monthly payment for the following year.

With either option, you will receive next year's Tax Notice in October next year, showing the balance of tax due. This program IS FOR NEXT YEAR'S TAXES AS PREPAYMENTS.
